

## DATA PROTECTION INFORMATION for the webinar

### **“Impact of the new EU IVD-Regulation on the daily life of the clinical Flow cytometry laboratory.”**

You have the right to request information on how your data is processed, a right to rectification of your data, to erasure (“right to be forgotten”), to have the processing restricted, to object to the processing, a right to data portability, as well as a right to withdraw your consent at any time. If you are of the opinion that we do not process your personal data properly, you have the right to lodge a complaint with a supervisory authority.
